- ❗ Please submit your application 3 to 4 weeks before travelling.
  - ❗ A separate application is needed for each person.
  - ❗ A visa is not required for entering Thailand for some EU Nationals, American, Canadian, Australian and New Zealand citizens, provided all of the following conditions can be satisfied:
    - a) Purpose of visit is tourism only.
    - b) Duration of stay is less than 30 days
    - c) Visitor is in possession of a pre-booked flight from Thailand within 30 days

## Application Guidelines

---

### STEP 1.

Complete and sign ONE application form. A separate form is required for each traveller regardless of age, including babies.

### STEP 2.

Submit with a completed application form:

- Passport – valid for at least six months from date of arrival in Thailand - Two recent passport size photographs.
- The appropriate fee (see Step 4).
- A registered self-addressed envelope with sufficient postage for the return of your passport.

### STEP 3.

For purpose other than tourism, please submit evidence substantiating your purpose of stay. Please see Types of Visa Page for a list of required documents.

### STEP 4.

Visa Fees are payable by Cash or Postal Order made payable to The Royal Thai Consulate Dublin

- Single Entry Tourist Visa: €35.00
- Double Entry Tourist Visa: €70.00
- Triple Entry Tourist Visa: €105.00

Single Entry Non-Immigrant Visa: €65.00 (N.B. For non-tourists only)

Multiple Entry Non-Immigrant Visa: €145.00 (N.B. For non-tourists only)

### STEP 5.

To avoid any delay in processing your visa, it is important to follow these instructions.

You must supply a self-addressed registered envelope with sufficient postage in order for your passport to be returned to you. Please remove covers from passports as they increase weight and therefore cost of postage. 2 or more passports will require extra postage.

Please note that Franked SAE's or SAE's which have postage coupons instead of stamps on them will not be accepted. Applicants from the North of Ireland can pay using a sterling postal order to the equivalent amount in Euros and need to include extra to cover registered postage as UK postage stamps cannot be used with in the Republic.

Apply for your visa about 3-4 weeks before the date of your departure.

Please allow at least 5 working days for the visa to be processed.

No responsibility can be accepted for financial loss associated with the application for a visa.

Be sure you will not need your passport while your visa application is being processed.
